VERMONT AVE. AT RAILROAD CROSSING AND PERMANENT CLOSURE OF WEST ADA (CITY OF GLENDORA) APRIL 9 - SEPTEMBER 25, 2021

CONSTRUCTION ACTIVITY

Crews will be fully rebuilding the railroad crossing on Vermont Ave. in the city of Glendora, as part of the 9.1-mile Foothill Gold Line light rail project. This work requires a **full closure of Vermont Ave. at the railroad crossing for approximately 5** ^{1/2} **months duration** which includes 10 weeks to allow for Frontier Communications to relocate their duct banks under the tracks. Crews will rebuild the existing roadway and add new curb, gutters, fencing, and soundwalls. As part of this work, **West Ada Ave will be permanently closed (at Vermont Ave) and become a cul-de-sac.** The permanent closure is required by the California Public Utilities Commission to improve safety along the corridor.

WHEN

Friday, April 9th and continuing daily thru September 25, 2021, Vermont Ave. will be fully closed to all traffic (vehicular and pedestrian) at the railroad crossing 24 hours a day/7 days a week. Route 66 (south of the crossing) and Glendora Ave. (east of the crossing) will remain open and accessible by way of detour routes, see map below.

- Friday, April 9th West Ada Ave. at Vermont Ave will be closed permanently and become a cul-de-sac.
- Crews plan to work daily during the hours of 7:00 AM 12:00 AM (Midnight), Monday Saturday. NOTE: Occasional longer work hours and construction on Sundays may be performed during the closure period.

TRAFFIC ADVISORIES

- Vermont Ave. will be temporarily closed to vehicular and pedestrian traffic at the railroad crossing.
- West Ada Ave. will be permanently closed to vehicular traffic at Vermont Ave.
- Access to homes and businesses on Vermont Ave. within the closure area north, south, and east of the railroad crossing will be maintained at all times.
- A detour route (see map below) will be in place during the closure and signage will be posted to direct motorists and pedestrians. Please follow detour signs.

PLAN YOUR ROUTE AND BE PREPARED

- ✓ Vermont Ave. will be fully closed to all traffic at the railroad crossing between Route 66 and Carroll Ave.
- ✓ Glendora Ave. (northbound and southbound) will serve as the main detour route, see details below.
- ✓ Route 66 and Carroll Ave. (eastbound and westbound) will remain open to all traffic.
- ✓ West Ada Ave. at Vermont Ave. will be permanently closed to all vehicular traffic and become a cul-de-sac.
